### 1. What is the purpose of this document?

This Cookies Notice is part of the Privacy Notice for the website hosting Conduct Watch platform (the "Website"). In the context of using the Conduct Watch Platform we use cookies to ensure that it is functioning effectively.

### 2. What is a cookie?

A cookie is a small text file placed on your device by the websites that you visit. Cookies are then sent back to the website on each subsequent visit, or to another webpage that recognizes that cookie. Cookies are used in order to make the website work, or to work more efficiently, as well as to provide information to the owners of the website. Such information may be used to provide a more personalized and responsive service. Cookies may be either first party cookies set directly by us to your device, or third-party cookies set by a third-party provider on our behalf. Whenever you use this Website, information may be collected through the use of cookies and other technologies.

The strictly necessary cookies we use on this Website could be categorized in the following high-level categories:

- Session cookies used to run the Website, also including facilitation of the session timeout countdown, user's timezone identification and ensuring the security of the Website and the user;
- Other cookies that enable identification of the device's browser type, orientation and operating system of the device, as well as the type of the mobile device used. It is noted that no association with an actual user identity(ies) takes place.

## 6. How long will cookies remain on my device?
